

# **COOLMORE & ASSOCIATED STUD FARMS REQUIREMENTS FOR THE 2012 BREEDING SEASON**

Please find below all requirements for mares visiting Coolmore Stallions.

## **NEGATIVE CEM CERTIFICATE**

A certificate from a recognised Irish, UK or French laboratory dated on or after 1<sup>st</sup> January, 2012 stating the mare is negative on one clitoral swab for:

**a) Pseudomonas b) Klebsiella c) CEM**

All mares in 2012 will be required to have a negative CEM swab taken at Coolmore regardless of whether they are **IN-FOAL** or **BARREN** to a Coolmore based stallion.

## **NEGATIVE EVA CERTIFICATE**

A certificate from a recognised Irish, UK or French laboratory dated on or after 1<sup>st</sup> January, 2012 stating the mare is negative.

Any mare from outside Ireland and the UK will require another EVA certificate from a recognised Irish or UK laboratory.

Mares with a stable or declining positive sample require 2 samples prior to leaving country of origin and 1 sample taken in Ireland prior to visiting a Coolmore stallion.

**Any mare in the USA in 2011 will require two clitoral swabs (fossa and sinuses) be taken at least seven days apart and an endometrial swab (cervical swab) taken during an oestrus period prior to covering.**

## **NEGATIVE EIA (Eliza or Coggins) Certificate**

All mares to be covered in 2012 should have a negative EIA certificate from a recognised laboratory dated on or after the 1<sup>st</sup> January from their country of origin.

Any mare from outside Ireland and the UK will require another EIA certificate from a recognised Irish or UK laboratory.

## **VACCINATIONS**

Mares arriving at Coolmore Stud to FOAL must have a minimum of 3 virus-abortion vaccinations recorded in their passport or a veterinary certificate. Mares without these vaccinations will not be allowed onto the farm until after they have foaled.

It is Coolmore Stud policy to vaccinate all mares with a Flu Vaccination plus EHV 4/1 programme.

## **FOREIGN FOALS BORN AT COOLMORE**

All foreign foals born at Coolmore will need to be registered with Weatherbys. Please provide covering certificate in order to complete registration. (For Irish owners that require their foals to be micro-chipped and blood typed please provide a blood typing kit.)

## **IN SEASON MARES**

Any mare arriving after 12 midday **WILL NOT** be checked until the following morning by our Vet. Mares will not be permitted to depart the farm until they have gone “out of season”. Mares will not be covered unless they have the required CEM, EVA, EIA certs and a copy of their markings. **ARRIVAL** and **DEPARTURE** of every animal must be notified to the farm office in advance.
